PROCEDURE FOR RECEIVING VACATION BENEFITS:

The Employee must submit written application on this form. An employee who does not apply for Vacation Benefits during the two consecutive Vacation Payout Periods (Plan Years) immediately following the Contribution Year during which the Employee became eligible for a Vacation Benefit shall forfeit that Benefit which shall be treated as an "Unclaimed Vacation Benefit" (see below).

LATE PAYMENT OF VACATION BENEFITS:

If the Fund office cannot locate an Employee at the address provided to the Administrator by the Employee, then the Employee has sole responsibility for notifying the Fund office of his change in location and new mailing address. If an Employee does not make written application for a Vacation Benefit during the current Vacation Payout Period, that Vacation Benefit shall carry over to the next Vacation Payout Period.

UNCLAIMED VACATION BENEFITS:

It is the intention of the Fund to use unclaimed benefits to help meet operating expenses of the Fund. Unclaimed monies shall be applied toward any operating deficit of the Fund which may not be covered by earnings. When unclaimed monies or earnings in excess of any amounts applied toward offsetting an operating deficit reach an amount deemed appropriate by the Trustees, those funds shall be pro-rated among employees drawing Vacation Benefits for the following year.
